Please join the CT Chapter of the Air & Waste Management Association (AWMA) for an insightful and lively discussion with CTDEEP's Commissioner Katie Dykes. Come hear firsthand what Ms. Dykes views as the top priorities, issues, challenges facing CTDEEP and the regulated community including Ms. Dykes 20 by '20 initiative. The 20 by '20 initiative will set forth 20 measurable process improvements between today and December 31, 2020 aimed at increasing predictability, efficiency, and transparency of DEEP's regulatory processes, with accountability provided through a public dashboard of key indicators.



Ms. Dykes was nominated by Governor Ned Lamont to serve as the Commissioner of CTDEEP, and was confirmed on February 20, 2019. She previously served as Chair of the Connecticut Public Utilities Regulatory Authority (PURA) from 2015-2018, and as Deputy Commissioner for Energy at Connecticut DEEP from 2012-2015. Katie also served as the Chair of the Board of Directors of the Regional Greenhouse Gas Initiative, Inc. (RGGI) from 2014 to 2017.
